PROCEDURE

A company or branch registration takes from four to six weeks in total. Requirements are the legal address, appointing official directors, and registered capital. Please visit our business services section for procedure description in each of the member states.

Manager or managers who are providing Administrative management of the company shall be legal residents or nationals of EU. We provide this service.

Clients may start their economic activities and earn profits all over the E.U. from the first day of the registration. The application for permanent residency and work permit usually takes six to eight months to complete; this time frame corresponds to that of work visa applications.

The big advantage is the possibility to offer one's own services and products to the European market immediately upon registration. We offer three service packages to our clients: basic cooperation package, advanced cooperation package, and complete cooperation package
